Treaties to which Spain is a Party Involving Questions of Public International Law, 1998

This section was prepared at the Department of Public International Law of the University of Málaga, by Dr. Alejandro J. This survey examines the treaties covered by article 2.1.a) of the Vienna Convention on the Law on Treaties, published in the *Boletín Oficial del Estado* (Official Journal of the State). Its purpose is to record the legal effects of these instruments, such as ratification or accession, municipal entry into force, provisional application, reservations or declarations, territorial application, and termination and abrogation. In a few instances some relevant articles or references will be included in the form of an unofficial translation.
