Treaties to which Spain is a Party Concerning Matters of Public International Law, 1997

This section was prepared by the Department of Public International Law at the University of Malaga, including Elena del Mar García Rico, Magdalena M. Martín Martínez and Alejandro J. Rodríguez Carrión, Professors of Public International Law, and Eloy Ruiloba García, Ana M. Salinas de Frías and M. Isabel Torres Cazorla, Research Associates in Public International Law. The survey includes the treaties covered by Art. 2.1.a) of the Vienna Convention on the Law on Treaties, published in the Boletín Oficial del Estado (Official Journal of the State). Its purpose is to record the legal effects of these instruments, such as ratification or accession, municipal entry into force, provisional application, reservations or declarations, territorial application, termination and abrogation. In a few instances some relevant articles or references will be reproduced in an unofficial translation.

Note: The following declarations are included in the ratification instrument:

- "1. The Kingdom of Spain notes that, as a member of the European Union, it has transferred competence to the European Community with regard to certain matters governed by the Convention. In due course, it will make a declaration specifying the nature and extent of the competence transferred to the European Community in conformity with the provisions of annex IX to Convention.
- 2. In ratifying the Convention, Spain declares that this act cannot be interpreted as recognition of any rights or situations relating to those maritime spaces of Gibraltar not covered by Art. 10 of the Treaty of Utrecht of 13 July 1713 between the Kingdoms of Spain and Great Britain. Spain also considers that Resolution III of the Third United Nations Conference on the Law of the Sea does not apply to the case of the colony of Gibraltar, which is subject to a process of decolonisation in which only the relevant resolutions adopted by the General Assembly of the United Nations are applicable.
 - 3. Spain is of the understanding that:
 - (a) The regime established in Part III of the Convention is compatible with the right of the bordering State to enact and enforce, in straits used for international navigation, its own regulations provided that such regulations do not interfere with the right of transit.
 - (b) In Art. 39, paragraph 3 (a), the word "normally" means "except for force majeure or serious difficulty".
 - (c) The provisions of Art. 221 do not deprive the State bordering a strait used for international navigation of the competences granted to it under international law with respect to intervention in cases of such casualties as are referred to in the above-mentioned article.
 - 4. Spain interprets:
 - (a) Articles 69 and 70 of the Convention to mean that fishing rights in the exclusive economic zone of third States by the fleets of developed States

- which are land-locked or geographically disadvantaged is conditional upon whether the coastal States in question have previously facilitated such access to the fleets of the States which had customarily fished in the exclusive economic zone in question.
- (b) Art. 297, without prejudice to its provisions relating to the settlement of disputes, is taken to mean that, under articles 56, 61 and 62 of the Convention, the powers of the coastal State for determining the allowable catch, its harvesting capacity and the allocation of surpluses to other States may not be considered as discretionary.
- 5. The provisions of Art. 9 of annex III shall not constitute an obstacle to the participation of Party States whose industrial potential may not permit them to participate directly as contractors in the exploitation and resources of the Area in the joint ventures referred to in paragraph 2 of that article.
- 6. In accordance with the provisions of paragraph 1 of Art. 287, Spain chooses the International Court of Justice as the means for the settlement of disputes concerning the interpretation or application of this Convention".

Provisional application: 29 January 1997.

Definitive entry into force: 4 December 1997 (BOE 25, 29.1.98).

- Announcement made on 1 August 1997 by the Technical Secretariat-General of the Spanish Foreign Office, on the amendments of the Operating Agreement concerning the International Telecommunications Satellite Organisation (INTELSAT), adopted at the 25th meeting of Party States, held in Singapore from 4-7 April 1995 (BOE 200, 21.8.97).

Entry into force: 11 September 1996.

- Announcement made on 10 November 1997, by the Spanish Foreign Office, of the Amendment to Art. Note: This Treaty, in an extensive preamble, established the general principles which must guide their mutual relations (international legality, sovereign equality, non-intervention in internal affairs, refraining from the threat or use of force, peaceful settlement of disputes, cooperation in the area of development, respect for human rights and the fundamental freedoms of all people and for communication and understanding between cultures and civilisations) and includes provisions which regulate bilateral political relations, economic and financial cooperation, cultural, legal and consular cooperation, and establishment of specific cooperation programmes.

- Cooperation Convention within the framework of the Latin-American Conference signed "ad referendum" in San Carlos de Bariloche (Argentina) on 15 October 1995 (BOE 80, 3.4.97).

Instrument of ratification: 24 January 1997. Entry into force for Spain: 11 March 1997.

- Announcement of 22 July 1997, by the Technical Secretariat-General of the Spanish Foreign Office, of the operations manual, Annex to the Cooperation Convention within the framework of the Latin-American Conference (*BOE* 228, 23.9.97).

Note: That announcement also establishes and regulates the coordination commission and parties responsible for cooperation within the framework of the Latin-American Conference of Heads of State.
